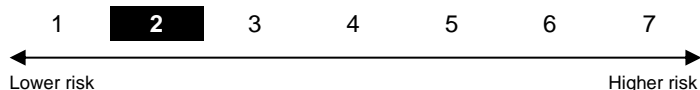
#### Objectives:

The investment objective of the Fund is to provide capital growth while targeting a relatively low level of portfolio volatility of between 30% to 50% of global equity market volatility over rolling three-year periods. The Fund intends to achieve its investment objective by gaining exposure primarily to a globally diversified portfolio of equities, bonds and alternative assets.

#### Intended Retail Investor:

Investors who prioritise reduced risk. It follows a strategy which aims for lower volatility, but which could produce lower returns over the medium term

### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



**The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to cash in early. You may have to pay significant extra costs to cash in early.**

#### Risk indicator
